The City of Grand View, Idaho is requesting Bids for the construction of the following Project:

Water System Improvements Project GV23-0300.01

Bids for the construction of the Project will be received at **Grand View City Hall located at 425 Boise Ave., P.O. Box 69, Grand View, ID 83624** until **May 8, 2024 at 10:00 AM** local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

Improvements to the City's drinking water system and includes the construction of a nitrate treatment system, new treatment building, piping and valving, pumps, electrical, controls, site improvements, approximately 4,100-feet of new 10-inch water main, and related improvements as specified in the plans and contract documents. Construction funding includes DEQ American Rescue Plan Act (ARPA) and Drinking Water State Revolving Loan Fund (DWSRF) funds. Davis-Bacon Wages are required for this project. Contractor shall comply with Equal Employment Opportunity requirements.

Bids are requested for the following Contract: **Water System Improvements/Contract Number GV23-0300.01**

Owner anticipates that the Project's total bid price will be approximately **\$2,561,000**. The Project has an expected duration of **365** days.
